Training for a 21st Century Fishing Career

As a collaboration between California Sea Grant and California's commercial fishermen, this program addresses the need for well-trained, entry-level crew members who will continue and grow our valuable, sustainable fishing industry

1. Workshop Training

- 120 hrs over 2-3 weeks hosted by CA Sea Grant
 - Safety, Seamanship and Navigation (40%)
 - Business and Marketing (35%)
 - Fisheries Science, Conservation and Practice (25%)
 - Boat and Gear Maintenance (10%)

• Includes all critical boating and safety certifications

2. Paid On-the-Job Training

- 1000 hrs over 6-12 mos. learning from fishermen
 - Boat and Gear Operations and Maintenance (60%)
 - Safety, Seamanship and Navigation (15%)
 - Business and Marketing (15%)
 - Fisheries Science, Conservation and Practice (10%)

Your responsibilities

- Provide comprehensive, industry-relevant training using this program's guidance and check lists
- Provide a safe, equitable and respectful work environment
- Maintain and submit monthly records of your apprentice's on-the-job training hours and achievements
- Pay your apprentice fair, entry level wages and consider helping with other training fees
- Provide reasonably continuous employment and/or consider co-sponsoring with other fishermen
- Ensure compliance with all current maritime regulations (e.g., Federal and State Labor Laws, U.S. Coast Guard regulations, and International, Federal and/or State fishing regulations)

• A reliable supply of diverse, well-screened, welltrained new crew who are likely to stay with you: the strong relationship between trainer and apprentice leads to high job satisfaction and loyalty
